#### PRIVACY NOTICE PURSUANT TO ART. 13 AND 14 OF REGULATION EU 2016/679

### 1. DATA CONTROLLER AND DATA PROTECTION OFFICER

**UniCredit S.p.A.** (hereinafter "**UniCredit"**) with registered office in Milan, Piazza Gae Aulenti 3, Torre A - 20154 Milan, as **Data Controller**, provides you the following information on the processing of your personal data, pursuant to the Regulation EU 2016/679 (hereinafter "**GDPR**").

### 2. CATEGORIES OF PERSONAL DATA AND PURPOSES OF PROCESSING

The personal data that UniCredit will process are those given to the latter as part of the initiative "UniCredit Foundation Unconference" of 3-4 / 06/ 2024 (hereinafter, "**Event**") and of the release of the Authorization to use the Images and name below, such as your name, surname, your image and your voice, (hereinafter, "**Personal Data**"). Your Personal Data may be used by UniCredit:

a) in photos, videos, recorded/filmed, and any other photographic and / or audiovisual material created and / or published on the occasion of the Event, together with any material provided by you (hereinafter, the "Material") in order to publish and communicate them externally and internally, on the various communication channels used by UniCredit, online and / or offline (e.g. Group Intranet and Group Institutional website) and / or on social networks (for example YouTube, Facebook, Twitter, etc.), websites and / or apps of the UniCredit Group, via television and Press, online and in paper, entertainment platforms, in order to advertise and promote the Event itself as well as promote the UniCredit image itself. In case of processing of Personal Data and in particular of your image published on websites, such as YouTube, LinkedIn, Twitter - considering that these sites are managed by third parties over which UniCredit has no control - keep in mind that the deletion of your image may be impossible, as it may require a disproportionate effort (for example, deletion may be very expensive and / or technically demanding);

# b) to execute the undertaken commitments referred to in the Authorization to use the Images and Name below.

#### 3. LEGAL BASUS OF PROCESSING

With reference to the purpose referred to in **paragraph 2.a**) above, the legal basis for the processing is your **consent** (pursuant to art.6.1 letter A, of the GDPR) that you are free to give or not and that you can in any case, withdraw at any time, without prejudice to the lawfulness of the processing based on the consent issued before your withdrawal.

With reference to the purpose referred to in **paragraph 2.b)** above, the legal basis for the processing is the need to carry out the **commitments** referred to in the Authorization for the use of images and the name and surname indicated below (necessity to perform the contract to which the data subject is a party, pursuant to art.6.1 let. B, of the GDPR).

The communication of your Personal Data in relation to the purposes 2.a) and 2.b) is optional. Your refusal to provide Personal Data will result in the impossibility for UniCredit to use the Personal Data in relation to the Event and for any publication related to it, for promotional purposes in the interest of UniCredit, as well as to carry out the commitments referred to in the aforementioned authorization.

#### 4. DATA PROCESSING MEANS AND STORAGE PERIOD

The processing of Personal Data will take place through electronic (or in any case automated) processing and manual processing, in order to guarantee the confidentiality, accuracy and security of the Personal Data. UniCredit, in fact, ensures the use of technical and organizational measures, suitable to guarantee a level of security appropriate to the risk, pursuant to art. 32 of the GDPR. UniCredit retains your Personal Data for the entire duration of the Event and for the period necessary to pursue the purposes for which it was collected, including commercial, advertising and promotional purposes, up to a maximum period of twenty-four (24) months from the date of issue of your consent (as indicated below), in addition to any period provided for by laws, if necessary, to exercise or defend a right before a Court.

#### 5. RECIPIENTS OF PERSONAL DATA

Your Personal Data may be processed by the following categories of recipients, authorized to process personal data, with reference to the data necessary for the performance of the tasks assigned to them and in accordance with the instructions given by UniCredit itself: employees of UniCredit or seconded by it; temporary employees, interns, collaborators, consultants and employees of external companies.

• the following Third Parties Marco Penso authorized by UniCredit to carry out activities related to: i) use of Personal Data and in particular of images and name and surname, including registration, publication, reproduction; ii) organization, management and promotion of the aforementioned Event; iii) management of the platform on which the Event will be held. Your Personal Data will be communicated to these subjects upon appropriate designation in the role of Data Processor or on the basis of the recognition of an autonomous Data Controller.

If necessary, for the aforementioned purposes, the data collected may be transmitted and accessible to the aforementioned recipients, also based in non-EU countries.

In such cases, the Data Controller guarantees the adoption of suitable measure, which ensure an adequate level of data protection, such as the use of standard contractual clauses for the transfer of personal data to non-EU countries.

## 6. DATA SUBJECT RIGHTS

UniCredit also informs that you have the rights referred to in art. 15-22 of the GDPR, including the right to access Personal Data held by UniCredit and know how they are used, to obtain the updating, rectification, modification, integration of data, deletion, or the limitation of the processing of Personal Data, as well as, in the cases provided for by law, the right to data portability. UniCredit also informs you that you have the right to lodge a complaint to the competent Authority for the Protection of Personal Data or alternatively appeal to the Judicial Authority.
